### NEW WATER TENDER

Thanks to a grant from the Federal Emergency Management Agency (FEMA) through the Assistance to Firefighters Grant (AFG), the District has acquired a new water tender to replace the home-built 1985 apparatus the District has relied on for nearly 40 years. This new 3000-gallon water tender, built by Rosenbauer, utilizes modern technology to enhance our impact. One such new feature is the addition of a portable tank. With this tank, SPFD can increase efficiency because the water tender can drop all of its water in the tank and then go fill. In contrast, before, the tender would have sat on scene until empty and then left to fill up, leaving the incident with only the water in the fire engine tank. This efficiency allows the firefighters to continue fighting fire knowing there's 3000 gallons of water on scene and more on the way.



#### DISTRICT UPDATES

**SPFD awarded another Grant**—Speaking of AFG grants, the District was awarded another grant for new portable radios, this time for \$380k, of which the district must cover 10%. This brings the district's total grant money in the last three years to just over \$1m.

**The Compliance Engine** – The District is partnering with Bryce's "The Compliance Engine to improve community safety by ensuring all occupancies with a fire suppression system are inspected on a regular basis. For more information, visit <u>thecomplianceengine.com/fire</u>

**Fire Prevention -** Fire prevention has been busy this quarter with 31 new project starts, 66k new square feet, 185 new sets of plans and over 130 inspections, Despite the volume, we routinely receive great praise for the work of Fire Marshal Ingolia and Inspector Hoop. Well done!

## THIS QUARTER AT SOUTH PLACER FIRE

The warm summertime weather brings many visitors to the lake's cool waters and increases wildfire activity, causing a slight uptick in call volume for the District. Our fire responses for the third quarter are typically more wildland-based and this trend looks to hold true for 2024. The rest of our emergencies follow the normal incremental increase for the summertime, showcasing our department's adaptability to seasonal changes. The District achieved a 90% response time of 9:09 from the time you call 911 until we arrive at your emergency. The Board goal is 8:00, and while we continue to improve, we are also changing our deployment model in January because decreased response times translate directly into enhanced safety for our communities and are critical in fulfilling our commitment to timely and effective emergency services.
