## NEWLY ELECTED DIRECTORS

Director Flanagan, a resident of Granite Bay for nearly four decades, previously served on the Granite Bay Municipal Advisory Committee (MAC).

"Fire service, fuel reduction, emergency response -- it's all so important to our community," said Flanagan. "The Chief would come to our MAC meetings and give updates on the

District's financial status. I became increasingly interested and, coupled with my experience in law enforcement, I thought I could add value to the District. I'm honored my fellow Granite Bay neighbors elected me to the Board."

Absolutely no stranger to emergency response and law enforcement, Flanagan served as a Sacramento County Sheriff's Officer for 25 years, as well as an appointed commissioner to the Placer County Fish & Game Commission for nearly a decade. He graduated with a degree in criminal justice from California State University, Sacramento.

An avid conservationist and fly-fishing angler, Flanagan has traveled the world for his beloved sport -- Zihautenejo, Alaska, and Cuba, to name a few locales. Flanagan was one of the founding members of Friends of Auburn Ravine, where he was instrumental in establishing Chinook Salmon and Steelhead Trout counts that proved the streambed of Auburn Ravine was an active spawning habitat.

Flanagan says he most looks forward to ensuring the District's fiscal sustainability and fostering a positive work environment.

Director Windeshausen previously served as Placer County Treasurer, including treasurer for all fire districts, for nearly 30 years. She has lived in the South Placer Fire Protection District for over 35 years.

"I care deeply about our community and understand South Placer Fire District's success, as well as its challenges,"

wrote Windeshausen in a September 2024 letter to the South Placer Fire District Board. "I have a working knowledge of local fire districts with particular expertise regarding budget and finance matters."

Windeshausen's in-depth 2017 report and analysis were integral to passing funding measures to increase revenue for the Foresthill and Penryn Fire Districts. She is active in the Loomis community and served 16 years on the Citizens' Oversight Committee for SPFD's Loomis Benefit Assessment.





## FIRE PREVENTION





Our Fire Prevention Division is the backbone of our community risk reduction efforts. Fire Marshal Jeff Ingolia and Administrative Assistant/Fire Inspector Katrina Hoop work tirelessly to ensure that building projects within the District are safe for our community. Their work includes reviewing commercial building plans for compliance with the District-adopted fire codes. They visit the construction sites numerous times throughout the building process to make sure that fire protection systems (alarms, sprinklers, hood, duct, etc.) and access to the business comply with the current code. Then, they conduct a final inspection and provide a final fire approval. For commercial property, the prevention division or an engine company returns to the site for an annual business inspection, even years after initial construction, to ensure the public is safe. This is just one aspect of community risk reduction, which also includes public outreach, public education, weed abatement, and numerous other efforts to keep our community safe.

## PREVENTION STATISTICS

Speaking of prevention, in 2024, the Fire Prevention Division was busy with 115 new construction projects, with nearly 600,000 square feet of building space added to the District. As part of the prevention process, they reviewed more than 800 sets of plans and inspected 570 properties. That's two sets of plan reviews and more than one inspection every day of the year.

#### THIS QUARTER AT SOUTH PLACER FIRE

The District experienced a 5% reduction in call volume, with a decrease in fires and medical calls, but a rise in service calls. This is common in the seasonal transition from the dog days of summer to the cooler weather of fall and the start of winter.

Total Calls - 1038 Fires - 20 Medical - 674 Hazardous Condition - 14 Service - 118 Good Intent - 160 False Alarm - 52 Italics = No fire involvement
